1. Spring Season Schedule – next few weeks

2. Player Eligibility

- Executive Board has fielded multiple requests for players transfers
- Players should be playing for the team of the school they attend
- If a player without a team, they should be playing for the team geographically close to them

-Question (Timberline): short on players. Can they advertise at South and Borah? Yes, but please follow the player eligibility rules and review transfer with TVWLL.

Follow-up: can students who try out with other clubs are cut play for Timberline? Answer, no teams shared that they are cutting players.

-Question (Eagle): can 8th graders play or not? Per TVWLL rules, 8th graders can play on JV teams only but cannot play up to Varsity. Each team does have their own rules on ages/grades to follow also.

3. TVWLL Season fees – discussion

- questions (Mountain View): due to increase in umpire fees? Yes, over 80% of costs.

- comment (Bishop Kelly): relieved to hear the number is lower than previously proposed. BK would still prefer to pay less and play fewer games.
